### SUCCESS SPOTLIGHT

Makaya B came to SOAR a year ago with a job history of work in direct care support and wanted to advance her career in the healthcare field. At intake she was working part-time at Ecumen. After coming to SOAR she enrolled in the Pathways to Prosperity CNA training at Community Action Duluth, with a longterm goal of enrolling in LSC's nursing program.

While attending CNA training, Makaya faced several barriers: access to childcare post training, transportation, rent payments during training, and unexpected health expenses. Her case manager at SOAR helped her navigate these barriers while she took training. After CNA training, Makaya furthered her credentials and took and completed our Trained Medication Aide training in February.

She now works full-time at Viewcrest Health Center making \$9k more per/year than before.
